## DECLARATION OF INTENT BETWEEN

## GIVEN THAT

1. the GRASSMED ASSOCIATION hereinafter referred to as "association" is constituted, pursuant to Legislative Decree 117/2017 of the Civil Code and is based in Mortegliano (UD), via Dante Alighieri n. 2. (Article 1 of the Staff Regulations). It is legally represented by Dr. Francesco Dotto who is its President.
2. The association was founded with the aim of spreading the culture of technical agronomic sports assistance by promoting and supporting the professional figure of the technician of the green sports areas (groundsman) and the director of the green sports areas (groundsmanager).
3. Among the aims of the association there are those of promoting education, education and professional training, pursuant to the law of 28 March 2003, n.53, and subsequent amendments, as well as cultural activities of social interest with educational purposes;
4. Instead, the identity of the association is to create the new figure of the groundsman in Italy through the MISE (Ministry of Economic Development) following art. Amendment No 25 on new reforms of the sports professions.
5. to promote dialogue with other organizations in the sector, to promote the relations of members with institutions both locally and at national and international level (Article 2 of the Statute).
6. the association has designed a training course for groundsman already recognized by the Piedmont region and, therefore, recognized throughout the national and European territory;
7. this training course includes an internship period of 80/100 hours, 120 / hours theory and 66 hours of practice in the field plus two refresher courses per year.
8. David Roberts Experienced field manager with a proven track record of working in the sports industry, as well as a member of the GMA and a teacher at Watford Grounds Training

He has worked in many areas of land maintenance, Premier Football Clubs, one of the best private schools, the procurement sectors and local authorities.

He has worked at a high level in football, cricket, rugby league, golf and many other sports.

He specializes in the maintenance, development and construction of outdoor spaces, landscaping, and new sports complexes.

1. the association is committed to promoting the groundsman school on the national territory and Mediterranean area.
2. the association undertakes to seek and identify a sports center that performs the function of national headquarters.
3. David undertakes to follow the teaching activity with his program reported by the association at online platform or in presence, collaborating in their training and, possibly, in following them during the internship phase.
4. David undertakes to promote the aims of the association also with foreign experts, for an advantageous return of image and for himself and for the association.
5. To foster close and effective collaboration within the project of this DDI, it is agreed to review annually the exact topics and scope of the cooperation activity.
6. The persons authorized by both partners are identified in the person of David Roberts and Giovanni Taverna on behalf of the association.

#### DATE OF ENTRY INTO FORCE

This DDI shall enter into force on the date of signature by both Parties.

#### CHANGES

This DDI may be modified or revised by written agreement between the parties involved.

#### CONCLUSION


